## Unbelievable Discrimination

The first story is from Fountain, Colorado, where a neighbor is threatening to sue the Giesege family to remove the ramp that their daughter needs to get into her home. The reason? Curb appeal! Say what? Click on the link, and you'll see a plain, inoffensive ramp. We're really not sure what is so unattractive, but ok, we all have our own tastes. You can read the whole story at [MSN](#). I suppose I would respect the story more if the creepy neighbor's name was listed instead of the family with the ramp...

The second story happened in Washington, D.C. If this is true, and no one has disputed it, it's almost worse, because we expect the nation's capital to be more civilized, more advanced, and more highly evolved than the rest of the us. According to the [Washington Post](#), two brothers visited the National Air and Space Museum. Max is 21 and uses a wheelchair. His brother, Jake, is 25 and does not use a wheelchair. They wanted to try the flight simulators, and were told that one was too risky, but that they could get tickets for the second one, the RIDE. When Jake went to help Max out of the chair and into the RIDE, "a supervisor came running over" and told Jake to put Max down. Next, (again - i'm thinking SHE should be named, not Max and Jake) this federal employee directed all of her comments to Jake, as though being in a wheelchair meant that Max was unable to communicate. The brothers have filed a "federal discrimination lawsuit against the National Air and Space Museum, alleging that they were denied access to flight simulators and publicly embarrassed" during their museum visit.

Each of these two stories showcases the continuing uphill climb to achieving what was intended 23 years ago with the Americans with Disabilities Act. Both stories are disturbing, especially in 2013.

## Digital Divide

The NY Times recently reported on "[Most of U.S. Is Wired, but Millions Aren't Plugged In](#)". "Administration officials and policy experts say they are increasingly concerned that a significant portion of the population, around 60 million people, is shut off from jobs, government services, health care and education, and that the social and economic effects of that gap are looming larger. Persistent digital inequality - caused by the inability to afford Internet service, lack of interest or a lack of computer literacy - is also deepening racial and economic disparities in the United States, experts say."

Attorney Lainey Feingold, a disability rights attorney, [responded](#) to the article by pointing out that people with disabilities are facing an even greater divide: "Internet use among householders with a disability is only 48% compared to 76% for householders with no disability". As Ms. Feingold highlights: "there is a digital divide for people with disabilities because of a lack of accessible online content."

We know how to make websites usable to everyone, but universal usability is not always implemented.
